1 2 MR. BRAUN: It's 10:07 on Tuesday, December . . . what's today's date? 3 4 MS. MULLIGAN: Twenty-first. MS. EADERESTO: Twenty-first. 5 6 MR. BRAUN: Twenty-first; thank you 7 everybody. 8 MR. CALLAHAN: First day of winter. MS. MULLIGAN: Yes. 9 10 MS. SCHEIDT: Winter solstice, out of 11 sight. 12 MR. BRAUN: This is a meeting of the Governance Committee of the Town of Brookhaven 13 14 Industrial Development Agency. A quorum is 15 present. 16 Lisa. 17 MS. MULLIGAN: Today's meeting has been 18 convened in accordance with Chapter 417 of the 19 laws of 2021 effective September 2, 2021 20 through January 15, 2022 permitting local 21 governments to hold public meetings by 22 telephone and videoconference. 23 Okay. So our agenda is relatively 24 brief. 25 The first item on the agenda is our

1 2 ethics policy, which was included in your 3 packets. As per our ethics policy, it's supposed 4 5 to be reviewed annually by our Governance 6 Committee, so we wanted to take this 7 opportunity to see if anyone had any edits or 8 concerns or comments to it. We will 9 officially adopt it in January like we do 10 every year, but I just wanted to give everyone a chance to review it. 11 12 Does anyone have any comments or 13 questions or concerns? MS. SCHEIDT: It looks comprehensive. 14 15 MR. GRUCCI: I have none. 16 MR. WEIR: I have none. 17 MS. SCHEIDT: Nothing to add. 18 MR. BRAUN: Do we need a resolution to 19 recommend it to the full board or is just a 20 consensus sufficient? 21 MR. WEIR: You can do a resolution to recommend it to the full board. 22 2.3 MR. GRUCCI: I move it. 24 MR. POLLAKUSKY: So moved. 25 MR. BRAUN: Somebody care to move it,

2 please? 3 MS. SCHEIDT: Felix and Gary have already taken care of that. 4 5 MR. BRAUN: Thank you very much. 6 Mr. Callahan? 7 MR. CALLAHAN: Yes. MR. BRAUN: Mr. Grucci? 8 9 MR. GRUCCI: Yes. 10 MR. BRAUN: Mr. Pollakusky? MR. POLLAKUSKY: Yes. 11 12 MR. BRAUN: Ms. Paprocky? MS. PAPROCKY: Yes. 13 MR. BRAUN: Ms. Scheidt? 14 15 MS. SCHEIDT: Yes. 16 MR. BRAUN: Mr. Braun votes yes. 17 The motion is carried. Thank you. 18 MS. LaPONTE: Included in the package 19 is the annual questionnaire that will be sent 20 out in accordance with the ethics policy also 21 for your review. 22 Any questions on that? 23 Similar to the one in the prior year. 24 Okay. 25 MR. BRAUN: Are there any updates to

1

2 that that have been recommended, either by the 3 ABO or anybody else? MS. LaPONTE: Not at this point. 4 5 MS. MULLIGAN: No. 6 MS. LaPONTE: We monitor the ABO, 7 anything that comes out we monitor, anything 8 that comes out with the OSC, so we haven't 9 received anything. 10 MR. BRAUN: Okay. MS. LaPONTE: So we continue to monitor 11 12 it annually. Well, not even annually, 13 throughout the year. MS. MULLIGAN: Yeah. 14 15 MR. BRAUN: Okay. 16 MS. LaPONTE: Lastly on the agenda, I 17 did want to make everyone aware of there's an 18 ethics inquiry, so I'm actually pulling 19 together a report and investigation about that 20 and I will get back to you if any questions. 21 MR. BRAUN: But it is not as yet 22 complete; is that correct? 23 MS. LaPONTE: No, no, no. 24 MS. MULLIGAN: But we just wanted you 25 to know that there was an inquiry and that it

is being looked into.

3 MR. GRUCCI: When it gets looked into, is it looked into in-house or do we have 4 5 somebody external that reviews it? 6 MS. LaPONTE: So I review it in 7 accordance with the policy and if I need be, I 8 can go elsewhere and I will discuss it amongst 9 the board, amongst our attorneys, amongst 10 anybody that I feel fit in any circumstances. 11 MR. BRAUN: Felix, Lori is the IDA's 12 ethics officer. 13 MS. MULLIGAN: Yes. MR. GRUCCI: No, I understand that. I 14 15 didn't know if she brought an outside agency 16 in to review it along with her. MS. LaPONTE: No. 17 18 MS. MULLIGAN: Our policy gives her 19 latitude to handle it as she feels it's 20 appropriate. 21 MR. GRUCCI: Great. Thank you. 22 MS. LaPONTE: And that's all I had at 23 this time. 24 MS. MULLIGAN: Okay. 25 MR. BRAUN: Are there any other

questions?

3 MS. SCHEIDT: Are we taking minutes of this meeting or are we just reporting the 4 5 recommendation? 6 MS. MULLIGAN: So this meeting is 7 recorded, it will be live streamed on our 8 website and then we will have a transcript of 9 this discussion put together, done. 10 MR. BRAUN: Lisa, do you have any 11 anything else? Lori? 12 MS. LaPONTE: No, this is just part of 13 our ongoing, we need the governance at least 14 once, two times a year, so --15 MS. MULLIGAN: Yeah. So this was just 16 our second Governance Committee meeting of 17 this year. 18 MR. BRAUN: Bill or Annette, anything 19 else to bring up? 20 MR. WEIR: I'm not aware of anything 21 else that needs to be brought up at this time. 22 MR. BRAUN: If not, I'll entertain a 23 motion to adjourn the meeting. 24 MR. CALLAHAN: So moved. 25 MR. WEIR: Annette, you don't have

2 anything else to bring up, do you? 3 MS. EADERESTO: I do not. 4 MR. WEIR: Okay. 5 MS. EADERESTO: I do not. 6 MR. WEIR: Sorry, Mr. Chairman. MR. BRAUN: I asked for a resolution on 7 8 the table; is there a second? 9 MS. SCHEIDT: Second. 10 MR. BRAUN: Thank you. On the vote, Mr. Callahan? 11 MR. CALLAHAN: Yes. 12 13 MR. BRAUN: Mr. Grucci? MR. GRUCCI: Yes. 14 15 MR. BRAUN: Ms. Paprocky? 16 MS. PAPROCKY: Yes. 17 MR. BRAUN: Mr. Pollakusky? 18 MR. POLLAKUSKY: Yes. MR. BRAUN: Ms. Scheidt? 19 20 MS. SCHEIDT: Yes. 21 MR. BRAUN: Mr. Braun votes yes. 22 Motion carried and we are adjourned. 23 MS. MULLIGAN: Yeah. Our next meeting 24 is January 12th. 25
