WHEREAS, to aid the Agency in determining whether the Facility may have a significant effect upon the environment, the Company has prepared and submitted to the Agency an Environmental Assessment Form and related documents (the "Questionnaire") with respect to the Facility, a copy of which is on file at the office of the Agency; and

NOW, THEREFORE, BE IT RESOLVED by the Agency (a majority of the members thereof affirmatively concurring) as follows:

Section 1. Based upon the Questionnaire prepared by the Company and reviewed by the Agency, and other representations and information furnished regarding the Facility, the Agency determines that the action relating to the acquisition, renovation, redevelopment, equipping and operation of the Facility in an "Unlisted" action, as that term is defined under SEQR. The Agency also determines that the Facility will not have a "significant effect" on the environment and, therefore, an environmental impact statement will not be prepared. This determination constitutes a negative declaration for purposes of SEQR. Notice of this determination shall be filed to the extent required by the applicable regulations under SEQR or as may be deemed advisable by the Chairman or the Chief Executive Officer of the Agency or counsel to the Agency.

Section 2. The Agency hereby finds and determines:

- (a) By virtue of the Act, the Agency has been vested with all powers necessary and convenient to carry out and effectuate the purposes and provisions of the Act and to exercise all powers granted to it under the Act; and
 - (b) The Facility constitutes a "project", as such term is defined in the Act; and
- (c) The Facility preserves the public purposes of the Act by preserving or increasing the number of permanent private sector jobs in the Town of Brookhaven. The Company has represented to the Agency that they will provide approximately fifty (50) full-time employees within two (2) years of project completion; and
- (d) The acquisition, renovation, redevelopment and equipping of the Facility and the leasing and subleasing of the Facility to the Company will promote and maintain the job

opportunities, health, general prosperity and economic welfare of the citizens of Town of Brookhaven, and the State of New York and improve their standard of living and thereby serve the public purposes of the Act; and

- (e) The acquisition, renovation, redevelopment and equipping of the Facility is reasonably necessary to induce the Company to expand its business operations in the State of New York; and
- (f) Based upon representations of the Company and counsel to the Company, the Facility conforms with the local zoning laws and planning regulations of the Town of Brookhaven, Suffolk County, and all regional and local land use plans for the area in which the Facility is located; and
- (g) The Facility and the operations conducted therein do not have a significant effect on the environment, as determined in accordance with Article 8 of the Environmental Conservation Law of the State of New York and the regulations promulgated thereunder; and

Holtsville Industrial, LLC, a limited liability company duly organized and validly existing under the laws of the State of New York, on behalf of itself and/or the principals of Holtsville Industrial, LLC and/or an entity formed or to be formed on behalf of any of the foregoing (collectively, the "Company") has requested the Agency's assistance with the acquisition of an approximately 6.0 acre parcel of land located at 1 Corporate Drive, Holtsville, New York (the "Land"), the renovation, redevelopment and equipping of an approximately 48,416 square foot building located thereon (collectively, the "Equipment" and "Improvements"; and, together with the Land, the "Facility"), all for lease by the Agency to the Company and to be subleased by the Company to a future tenant or tenants not yet determined (the "Tenants"), for use as manufacturing, distribution, warehouse and miscellaneous office space. Thank you for providing the opportunity to address the pending application as it relates to One Corporate Drive, Holtsville.

The district generally supports economic development and the efforts of the IDA to promote job creation in the community. The district, however, also takes seriously any and all matters that could have an adverse impact on the district and its revenue sources. PILOTS, unintentionally, can decrease the school district tax base and, thus, increase the tax burden on the residents.

The proposed PILOT calls for payments of \$50,634 in year one, escalating to \$60,512 in year 10. The current tax bills on this property are approximately \$175,000. At the same proportions, the district stands to lose nearly \$83,000 in tax revenues on this property which will then be borne by other taxpayers.

In the application documents, applicant's counsel refers to a reduced assessment. It is unclear whether this decrease results from a reduced assessment or due to benefits proposed by the PILOT.

The district is ready and willing to engage in conversation with the applicant to further understand the impact of this project.

The district reserves its right to make an additional written statement prior to IDA action on this application.

RESOLUTION OF THE TOWN OF BROOKHAVEN INDUSTRIAL DEVELOPMENT AGENCY AUTHORIZING AN INCREASE OF SALES TAX AND USE TAX EXEMPTIONS AND MORTGAGE FINANCING AND THE EXECUTION AND DELIVERY OF LOAN DOCUMENTS IN CONNECTION THEREWITH FOR THE HOLTSVILLE INDUSTRIAL LLC 2018 FACILITY AND APPROVING THE FORM, SUBSTANCE, EXECUTION AND DELIVERY OF SUCH RELATED DOCUMENTS

WHEREAS, by Title 1 of Article 18-A of the General Municipal Law of the State of New York, as amended, and Chapter 358 of the Laws of 1970 of the State of New York, as the same may be amended from time to time (collectively, the "Act"), the Town of Brookhaven Industrial Development Agency (the "Agency"), was created with the authority and power among other things, to assist with certain industrial development projects as authorized by the Act; and

WHEREAS, the Agency previously assisted in the acquisition of an approximately 6.0 acre parcel of land located at 1 Corporate Drive, Holtsville, New York (the "Land"), the renovation, redevelopment and equipping of an approximately 48,416 square foot building located thereon (collectively, the "Equipment" and "Improvements"; and, together with the Land, the "Facility"), all for lease by the Agency to Holtsville Industrial, LLC, a limited liability company duly organized and validly existing under the laws of the State of New York (the "Company") and to be subleased by the Company to a future tenant or tenants not yet determined (the "Tenants"), for use as manufacturing, distribution, warehouse and miscellaneous office space; and

WHEREAS, the Agency, by resolution duly adopted on February 21, 2018 (the "Authorizing Resolution"), authorized the acquisition, renovation and equipping of such facility and the execution and delivery of the Agency Documents (as defined therein); and

WHEREAS, the Company leased the Facility to the Agency pursuant to a certain Company Lease Agreement, dated as of February 1, 2018 (the "Company Lease"), between the Company and the Agency, a memorandum of Company Lease was to be recorded in the Suffolk County Clerk's office; and

WHEREAS, the Agency currently leases the Facility to the Company pursuant to a certain Lease and Project Agreement, dated as of February 1, 2018 (the "Lease Agreement"), between the Agency and the Company, a memorandum of Lease Agreement was to be recorded in the Suffolk County Clerk's office; and

WHEREAS, pursuant to the Authorizing Resolution, the Agency authorized up to \$43,125, in exemptions from sales and use taxes; and

WHEREAS, the Company has requested the Agency's consent to increase the exemptions from sales and use taxes in order to complete the acquisition, renovation and equipping of the Facility (the "Increase"); and

WHEREAS, to provide for the Increase, the Agency and the Company will enter into a certain Letter Agreement, dated as of August 21, 2019, or such other date as may be determined by the Chairman, Chief Executive Officer and counsel to the Agency (the "Letter Agreement"), by and between the Agency and the Company; and

WHEREAS, the Company and the Agency previously mortgaged their respective interests in the Facility to National Educators Federal Credit Union (the "Original Lender") by entering into a Mortgage, Assignment of Rents and Security Agreement, dated on or about February 27, 2018 (the "Original Mortgage"), in the aggregate principal amount of \$3,185,000, which Mortgage was to be recorded in the Suffolk County Clerk's office; and

WHEREAS, the Company has now requested that the Agency consent to enter into a refinancing with Bridgehampton National Bank (the "2019 Lender") with respect to the Facility in the principal amount presently expected to be \$3,185,000 but not to exceed \$3,500,000 (the "2019 Loan"); and

WHEREAS, the proceeds of the 2019 Loan will be used to satisfy the Original Mortgage; and

WHEREAS, as security for such 2019 Loan being made to the Company by the 2019 Lender, the Company has submitted a request to the Agency that it join with the Company in executing and delivering to the 2019 Lender one or more mortgages and such other loan documents, satisfactory to the Agency, upon advice of counsel, in both form and substance, as may be reasonably requested by the 2019 Lender (the "2019 Loan Documents"); and

WHEREAS, the Agency contemplates that it will provide financial assistance to the Company consistent with the policies of the Agency, in the form of (i) additional exemptions from sales and use taxes in an amount not to exceed \$21,562, for a total amount not to exceed \$64,687, in connection with the purchase or lease of equipment, building materials, services or other personal property with respect to the Facility, all consistent with the policies of the Agency, and (ii) exemptions from mortgage recording taxes, to the extent allowed by law, for one or more mortgages securing the principal amount presently estimated to be \$3,185,000 but not to exceed \$3,500,000 in connection with the financing or refinancing of the acquisition, renovation and equipping of the Facility and any future financing, refinancing or permanent financing of the costs of acquiring, renovating and equipping the Facility; and

WHEREAS, the Act authorizes and empowers the Agency to promote, develop, encourage and assist projects such as the Facility and to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York;

WHEREAS, the Company has agreed to indemnify the Agency against certain losses, claims, expenses, damages and liabilities that may arise in connection with the transactions contemplated by the increase of exemptions from sales and use taxes and the financing or refinancing of the Facility and the continued leasing and subleasing of the Facility.

NOW, THEREFORE, BE IT RESOLVED by the Agency (a majority of the members thereof affirmatively concurring) as follows:

Section 1. The Agency hereby finds and determines:

- (a) By virtue of the Act, the Agency has been vested with all powers necessary and convenient to carry out and effectuate the purposes and provisions of the Act and to exercise all powers granted to it under the Act.
- (b) The Facility continues to constitute a "project", as such term is defined in the Act.
- (c) The Facility preserves the public purposes of the Act by increasing the number of private sector jobs in the Town of Brookhaven.
- (d) The financing or refinancing of the acquisition, renovation and equipping of the Facility will promote and maintain the job opportunities, health, general prosperity and economic welfare of the citizens of the Town of Brookhaven, Suffolk County and the State of New York and improve their standard of living and thereby serve the public purposes of the Act.
- (e) The financing or refinancing of the acquisition, renovation and equipping of the Facility as contemplated in this resolution is reasonably necessary to maintain the competitive position of the Company in its industry.
- (f) Based upon representations of the Company and counsel to the Company, the Facility continues to conform with the local zoning laws and planning regulations of the Town of Brookhaven and all regional and local land use plans for the area in which the Facility is located.
- (g) The Letter Agreement will be an effective instrument whereby the Agency will grant the Increase to the Company.
- (h) It is desirable and in the public interest for the Agency to assist in the financing or refinancing of the acquisition, construction and equipping of the Facility.
- (i) The 2019 Loan Documents will be effective instruments whereby the Agency and the Company agree to secure the 2019 Loan and assign to the 2019 Lender their respective rights under the Lease Agreement (except the Agency's Unassigned Rights as defined therein).

Section 2.

In consequence of the foregoing, the Agency hereby determines to: (i) approve the Increase, (ii) approve the form and substance of the Letter Agreement, (iii) authorizes the execution and delivery of the Letter Agreement and such other related documents as may be necessary or appropriate to effect the Increase, (iv) grant a mortgage on and security interest in and to the Facility pursuant to a certain mortgage and security agreement for the benefit of the 2019 Lender (the "2019 Mortgage"), (v) authorize the execution and delivery of the 2019 Mortgage, and (vi) execute, deliver and perform the 2019 Loan Document to which the Agency

is a party, as may be necessary or appropriate to effect the 2019 Loan or any subsequent refinancing of the 2019 Mortgage.

- Section 3. Subject to the provisions of this resolution and the Lease Agreement, the Agency is hereby authorized to do all things necessary or appropriate for the execution, delivery and performance of the Letter Agreement, the 2019 Loan Documents and 2019 Mortgage, and such other related documents as may be necessary or appropriate to effect the Letter Agreement, the 2019 Loan, or any subsequent refinancing of the 2019 Loan, and all acts heretofore taken by the Agency with respect to such financing or refinancing are hereby approved, ratified and confirmed.
- Section 4. Subject to the provisions of this resolution and the Lease Agreement, the Agency hereby authorizes and approves the following economic benefits to be granted to the Company in the form of (i) exemptions from sales and use taxes in an amount not to exceed \$64,687, in connection with the purchase or lease of equipment, building materials, services or other personal property, consistent with the policies of the Agency, and (ii) exemptions from mortgage recording taxes, to the extent allowed by law, for one or more mortgages securing the principal amount presently estimated to be \$3,185,000 but not to exceed \$3,500,000 in connection with the financing or refinancing of the acquisition, renovation and equipping of the Facility and any future financing, refinancing or permanent financing of the costs of acquiring, renovating and equipping of the Facility.

Section 5.

- (a) Subject to the provisions of this resolution and the Lease Agreement; the Chairman, Chief Executive Officer, and all other members of the Agency are hereby authorized, on behalf of the Agency, to execute and deliver the Letter Agreement, the 2019 Mortgage and 2019 Loan Documents, together with such other related documents as may be, in the judgment of the Chairman and Agency Counsel, necessary or appropriate to effect the transactions contemplated by this resolution (hereinafter collectively called the "Agency Documents"). The execution thereof by the Chairman, Chief Executive Officer, or any member of the Agency shall constitute conclusive evidence of such approval; and
- (b) the Chairman, Chief Executive Officer, and any member of the Agency are further hereby authorized, on behalf of the Agency, to designate any additional authorized representatives of the Agency.
- Section 6. Subject to the provisions of this resolution and the Lease Agreement, the officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required or provided for by the provisions of the Agency Documents, and to execute and deliver all such additional certificates, instruments and documents, pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing resolution and to cause compliance by the Agency with all of the terms, covenants and provisions of the Agency Documents binding upon the Agency.

Section 7. Any expenses incurred by the Agency with respect to the increase in sales and use tax exemptions and financing or refinancing of the Facility shall be paid by the Company. The Company has agreed to pay such expenses and further shall agree to indemnify the Agency, its members, directors, employees and agents and hold the Agency and such persons harmless against claims for losses, damage or injury or any expenses or damages incurred as a result of action taken by or on behalf of the Agency in good faith with respect to the financing or refinancing of the Facility.

<u>Section 8</u>. This resolution shall take effect immediately.
