THE TOWN OF BROOKHAVEN INDUSTRIAL DEVELOPMENT AGENCY ("AGENCY") RESOLUTION TO COMMENCE PROCEEDINGS TO ACQUIRE TITLE TO REAL PROPERTY IN FURTHERANCE OF THE AGENCY'S FEBRUARY 14, 2022 DETERMINATION AND FINDINGS

WHEREAS, the Town of Brookhaven Industrial Development Agency (the "Agency"), at its meeting of February 14, 2022, adopted, by Resolution No. ______, a "Determination and Findings," pursuant to the New York State Eminent Domain Procedure Law, a copy of which is annexed hereto as Exhibit A; and

WHEREAS, the Determination and Findings identified twenty-eight (28) parcels of real property as necessary to the redevelopment of the Ronkonkoma Hub Redevelopment Project (as defined in the Determination and Findings); and

WHEREAS, the Agency authorized, at paragraph 55 of the Determination and Findings, its attorney to proceed to acquire title to the twenty-eight (28) parcels of real property via eminent domain; and

WHEREAS, the Master Developer (as defined in the Determination and Findings) has determined that the acquisition of title to the following six (6) of the above-referenced twentyeight (28) parcels of real property is required at this time in order to continue to develop the Ronkonkoma Hub Redevelopment Project

NOW, THEREFORE, BE IT RESOLVED, that the Agency authorizes its attorneys to take all steps necessary to acquire title to the Subject Properties in the name of the Agency in accordance with applicable law.
